
SC COURT OF APPEALS

The other doctors i have not been able to get to see them, But i am working as fast as possible to do so.

This is very sressfull i am trying to do as the court wants me to do also keeping up with the doctors appointments still trying to learn legal words and talk and now having more trouble with body parts getting worse and extra doctor visits go back through all the documents that i have been trying to get entered into the hearings and now that the lady at the workers comp company wants to offer a settlement, THIS IS WHY i don't understand why i'm not allowed to have a lawyer to get me through this with the knowledge to keep this from being one sided as it has been from the very first hearing

this would have been over a long time ago if this had been possible and as i have said from the start WITH THE FIRST LAW FIRM LOSEING LEGAL AND PICTURED documents i should have been ordered a new hearing on April 22, 2006 when i asked for it !! I have to live from day to day i do not have the money to keep up with someone who has plenty, but i must fight to get just the truth as i know it sence the workers comp company that is again'st me is wanting to try to settle this has changed all that i am working on I WILL get the correct documents in to her as soon as the doctors allow me to see them and show the incorrect papers that were sent to the MSA office.
