You knew what you were doing from the start and I played along. That's too bad. God knows as he watches the misery you try to cause that lives inside of you.

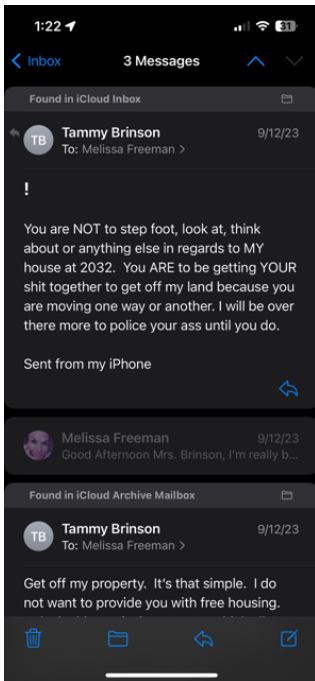

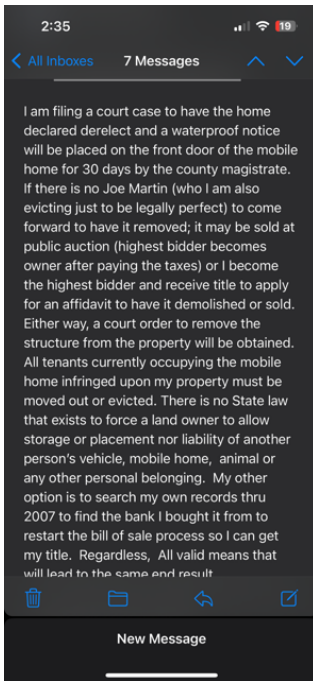

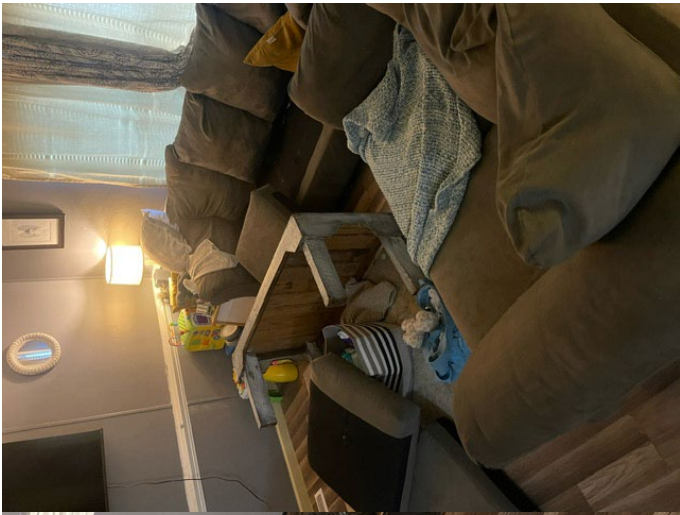
