
INDICTMENT

At a Court of General Sessions, convened on November 16, 2021, the Grand Jurors of Fairfield County present upon their oath:

ASSAULTING, BEATING, OR WOUNDING LAW ENFORCEMENT OFFICER

That Tyshawn Cornelius Robinson did in Fairfield County on or about September 26, 2021, knowingly and wilfully assault, beat, or wound Deputy Goodwin of the Fairfield County Sheriff's Office, a law enforcement officer, engaged in serving, executing, or attempting to serve or execute a legal writ or process or assault, beat, or wound the officer when the defendant was resisting an arrest being made by the officer, whom the defendant knew or reasonably should have known was a law enforcement officer in violation of § 16-9-320(B), *Code of Laws of South Carolina, (1976), as amended.*

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
