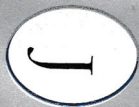

Dear Sophie Vick. First of all, I am happy to report that I got my new phone working, so YES, I can talk to you at 1:30 tomorrow! Secondly, the federal employees LIVING in SC won't be able to do anything about what is going on in this state without risking their own and their family's safety because the Attorney General (AG), SC Law Enforcement Division (SLED) and local Sheriffs are conspiring to obstruct justice and violate civil rights! To pick up where I left off yesterday, I realized I did NOT attach copies of Judge Robert Hood's or Jennifer Davis's emails. I don't just want you to take my word for what I am telling you is going on; I'm trying to make sure I attach proof (attachments 1&2). I arrived at Alvin S. Glenn Detention Center (ASGDC) just before noon on 1/20/23 and they didn't want to let me in. I was supposed to be brought in by the arresting agency, SLED but a family member brought me, and I insisted they let me in because the judge threatened to resentence me for the full five years ACTIVE if I was NOT there by noon. I stayed in a holding cell with two other females that were waiting for bond hearings until 3am the next morning and then was taken to Goff ward and taken to an unoccupied cell that the toilet was broken, and sink was running, so I told the guard that brought me in I needed another cell and was taken to G2 that I shared with Rebecca Davidson, a homeless woman from Chicago with her hair matted to the back of her head. The other inmates called her "Two Step" because she takes two steps out the door and is right back again! When the guard would POP the locks, ours stuck and did NOT open, so we would have to find a passerby willing to tell the guard to POP it again while they pulled from the outside. We missed getting food twice in the week I was there because we could NOT get out of the cell. I had a heart catheterization in 2010 and told the ASGDC doctor I need caffeine, magnesium and salt. He told me I could order coffee and salt from the commissary, and he didn't have magnesium. When it rained, the ceilings leak, and our cell floor was full of water and the sink ran constantly. Multiple times other inmates caught rats in their belongings. The last two nights I was there we were locked down from 5pm until the next morning because they were short staffed and didn't have a guard to be in with us. If anybody had gotten hurt or had a medical emergency and called for help, nobody could have heard us! Attachment #3 is a screenshot of the email I sent to Richland County (RC) Sheriff Leon Lott about a black female, day shift Supervisor passing contraband to an inmate and how we had NO guard with us that evening, while the party was happening and then weren't locked down until after 11pm. I wound up being arrested and prosecuted because I disrupted millions of dollars in the theft of federal foreclosure properties and federal mortgage money, which is how law enforcement is being paid off! In 2008 I registered AAA Mission of Charity (AAAMOC) with the IRS and SC Secretary of State (attachments 4 & 5). In 2014 after a federal foreclosure property at 124 Bakersland Road, Chapin, SC 29036 (124BLR) failed to sell multiple times on Auction.com with a reserve of \$75,000.00 (amount seller will accept) I contacted the listing real estate agent Ann Milligan who refused to write a purchase offer contract. I used AAAMOC's check, paid the \$4,365.60 delinquent property taxes (attachment 6) and mailed a purchase offer directly to trustee JP Morgan Chase Bank (JPMCB) in Columbus, Ohio. On 7/2/14 a Special Warranty Deed (SWD), Quit Claim Deed (QCD) and Mortgage were delivered to RC Register of Deeds (attachments 7-12) showing a purchase price of \$88,725.00. Why would anyone pay more than ten thousand more than the seller is asking for a property, so I contacted Sheriff Leon Lott. Howard Hughes sent me an email that everything was above board and AAAMOC would be getting a refund (attachment 13) but didn't. On 1/7/15 purchaser Ashley Shaffer sent a letter to AG Wilson and a signed copy to me stating on page 2 line 3 "...and while the taxes reflect the selling price, it is not fraud" (attachments 14 & 15). Ashley Shaffer had received scholarship money from the SC House of Representatives in a Bill sponsored by MORTGAGE LENDER Nathan Ballentine, formerly employed by Wells Fargo until I contacted them in 2015 (attachments 16 & 17). Instead of arresting Ashley Shaffer (now Jackson) and her grandmother (supposed mortgage lender) Barbara Periera that lives at 124 White Rock Acres Road, Chapin, SC 29036 for FORGERY and RECEIVING STOLEN GOODS in excess of \$75,000.00, the 2013 property taxes were rebilled and on 3/11/15 the law firm Morris Hardwick Schneider (MHS) supposedly paid them again (attachment 18), which is impossible, Hardwick was ousted in August 2014 and the law firm's name changed to Morris Schneider Wittstadt, in 2015, MHS no longer existed. The reason this is all relevant is because federal foreclosure properties and properties that won't pass a title search are being used to pay off law enforcement officials and then federally backed mortgages are obtained and the closing attorney doesn't send the promissory note to the lender and after a year or two a lost mortgage satisfactions are sent to the register of deeds. McKenzie Anne Lott is the 21-year-old daughter of Richland County (RC) Sheriff Leon Lott, that has jurisdiction over Alvin S. Glenn Detention Center. McKenzie Lott and my daughter are the same age and went through Lake Murray Elementary, Chapin Middle and Chapin High Schools together, both graduated in 2021. Attachments 19-22 show where 6627 Dare Circle, Columbia, SC has a tax value of \$212,000.00 but McKenzie supposedly purchased it in April of 2023 for \$349,000.00, the property wouldn't appraise for that much NOW but next year RC will reassess it based on the most recent selling price, then it will qualify for a \$349,000.00 mortgage. McKenzie Lott gets a FREE house and Sheriff Leon Lott will be paid off \$349,000.00 most likely using a federally backed mortgage initiated by Nathan Ballentine from the SC House of Representatives! Still lots more to tell and show you but I need to stop here or the email won't transmit! As usual sending a copy to myself and looking forward to talking with you tomorrow, although there really isn't much more I can tell you about Alvin S. Glenn than what I have conveyed in this email. Thank you for the background here - these events are not within the scope of our investigation. I shared your concerns with the US Attorney's Office in South Carolina and they are preparing a written response to you. I don't mean to discourage you, though! You should send things that aren't directly related to Alvin S Glenn (as outlined below) to [tousasc.civilrights@usa.doj.gov](mailto:tousasc.civilrights@usa.doj.gov).

Our investigation is focused on two current/recent aspects of Alvin S Glenn Detention Center - living conditions and protection from harm due to violence from incarcerated individuals. In the email that was forwarded to me, you were recounting an incident from January where you believed COs were providing contraband to incarcerated people. I was hoping to talk more with you about this and other experiences you had in January while at Glenn.

Are you available to talk tomorrow (11/29) at 1:30? I can call you.
