OF THE FILING DEADLINES SET BY RULE 207 OF THE SCACR


Appellants now request permission to order the transcript outside of the filing deadlines set by Rule 207 of the SCACR.



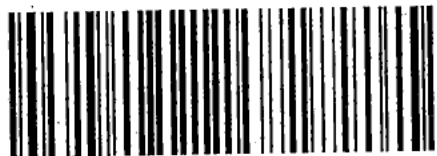

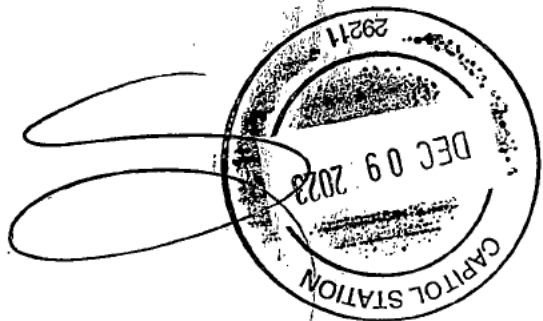
