I Mytazis Nesmith is writing you about some very important matters, that I should address about my previous case & Pro Bono Attorney. First I'm requesting for a "Post-conviction relief (PCR) Packet". I would like to receive a Post-conviction relief (PCR) Packet due to the poor representation done by attorney Ralph J. Wilson Sr. Attorney Ralph Wilson stated on his own behalf that I (defendant) was reacting on self-defense and I was supposed to have a Stand your ground hearing. He stated this at my second bond hearing when my bond was in consideration. I never had an Stand your ground hearing nor did I ever talk to my attorney about my case until the week before my trial was supposed to start. My lawyer told me "IF I was too plea out to Voluntary Manslaughter I would've receive 10-15 years". I would like for my case to be reopened and reviewed. Here are some evidence pertaining my case and SLED Report also proves that my weapon wasn't even fired at the scene. I explained this to my attorney but he wasn't trying to hear me out. So I'm writing him up for Ineffective Counseling.

The solicitor also mentioned to me that "He knows I'm not the killer" so why was I sentenced like a killer it doesn't add up to me at all. This case wasn't fair since day 1, where is the justice? In their eyes I was guilty since day 1. Please look over my case, if I can't receive immediate release, I'm seeking a sentence reduction. I have been unlawfully detained since December 2, 2021.
