I am in receipt of your letter this day concerning the motion for extension that was filed on December 15, 2023. 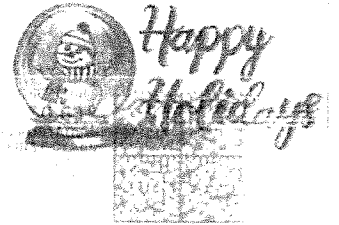
