I, Elvis Paulino, owner and operator of 24/7 towing, received a service call from Jason Alverson on July 22nd 2022 requesting towing services to remove 3 vehicles that were left on his property located at 213 Baker Rd, Simpsonville SC

I picked up the 3 vehicles and took them to our tow yard on 07/22/2022. We then started the process to inform the registered owners of the vehicles that their vehicles were at our tow yard and the fees that were due before we would release their vehicles to them. Mr. Jones was not the registered owner of any of the vehicles.

We went through the required process by first notifying the registered owners and waiting the required time before submitting them to the court. The court granted us ownership of the 3 vehicles on 11/17/2022. (proof attached)

I chose to represent myself in this matter, without the assistance of a lawyer, because I believe I did everything as I was supposed to and I was personally named on the court documents by Mr. Jones, in addition to my business, 24/7 towing. I am unaware of any requirement for me to hire a lawyer to assist me with this matter.


