Re: Lawyers' Fund for Client Protection Claim against Tara Dawn Shurling

Dear Adrain:

You recently filed a Lawyers' Fund for Client Protection claim against suspended attorney Tara Dawn Shurling. This claim is pending and will be investigated. However, there will be a delay in resolving your claim.

The rules establishing the Lawyers' Fund provide: "The payment to any applicant shall not exceed the sum of \$40,000 per claim; provided, however, that the aggregate total of claims paid per attorney shall not exceed \$200,000." At this time the Lawyers' Fund Committee is holding all claims against Tara Dawn Shurling for a period of at least six (6) months in order to give all clients the opportunity to file claims. This will allow our Lawyers' Fund Committee time to gather information and determine if awards will exceed the limitations, which may require prorating awards.
