UNOPPOSED MOTION FOR EXTENSION OF TIME
TO FILE APPELLANT’S INITIAL REPLY BRIEF

Pursuant to Rules 208(a)(3) and 240 of the South Carolina Appellate Court Rules, Appellant respectfully requests a second 10-day extension of time to file his Initial Reply Brief. This request is necessitated because Appellants’ counsels’ other case demands and filing deadlines, including the fact that undersigned counsel is currently preparing a brief on an expedited schedule set by the South Carolina Supreme Court in an original jurisdiction matter (*Eidson et al. v.
