**JOINT MOTION TO DISMISS APPEAL AS BETWEEN  
QUATTLEBAUM AND RASH ONLY FOLLOWING  
APPROVAL OF WRONGFUL DEATH SETTLEMENT**

Appellant/Respondent Darleen Rash (“Rash”) and Respondent/Appellant Paul Quattlebaum (“Quattlebaum”), by and through their undersigned attorneys, hereby jointly request the Court to dismiss the instant Appeal as between Rash and Quattlebaum, *only*.

Upon remand pursuant to this Court’s Order dated October 27, 2023, the trial court entered an Order For Approval of Settlement As To Plaintiffs and Defendant Quattlebaum Only dated December 19, 2023. The approved settlement between Rash and Quattlebaum fully and finally resolves all issues between those parties in the underlying action and in the instant appeal with both sides having agreed to bear their own fees and costs. The requested dismissal of the appeal as

between Rash and Quattlebaum has no effect on any other parties or issues before the Court on appeal.
