APPELLANT'S MOTION FOR ENLARGEMENT OF TIME TO FILE REPLY


Pursuant to Rule 240(f), SCACR, Carol Ann Honeycutt (hereinafter "Appellant") respectfully requests an enlargement of time within which to file its Reply to Respondent 25th Avenue, LLC's (hereinafter "Respondent") Return to Appellant's Motion to Reinstate.

Appellant has not yet received the Respondent's Return via regular U.S. Postal Mail as of today's date, Friday, January 5, 2024. Appellant went to the office of the attorneys for the Respondent on January 5, 2024, and was told by the receptionist that the documents were not available because no one was in the office to provide the Respondent's Return to the Appellant. 
