NOTICE OF APPEAL

Pursuant to Rule 203, SCACR, Defendants Amazon.com, Inc.; Amazon.com, LLC; Amazon.com Services, Inc; and Amazon Logistics, Inc. (collectively, Amazon) hereby timely appeal from the verdict and judgment in this case (attached) the Order of the Court holding that the request for ten days to file post-trial motions was untimely and thus such motions would not be considered (order attached), and any other adverse rulings to Amazon prior to and during the trial.¹
