I wanted to tell you as soon as possible and already notified ODC that I made a mistake in a report I motioned to keep private.

I was mistaken when I said in the report I sent yesterday that Chayban broke no contact on 5/6/2021 when he texted to harass me, gleeful about my son's misfortune and harassing me about my religion. He did break no contact hundreds of times, but the no contact order wasn't in place until the following month. So, he was just harassing me at that point and not violating the no contact order in the assault on my son yet.

It starts to run together because it has been so much and there were so many incidents right around that same time, before and after the order was in place.

I am very sorry. I will update it, but wanted to let the Court know as soon as possible that I misspoke.

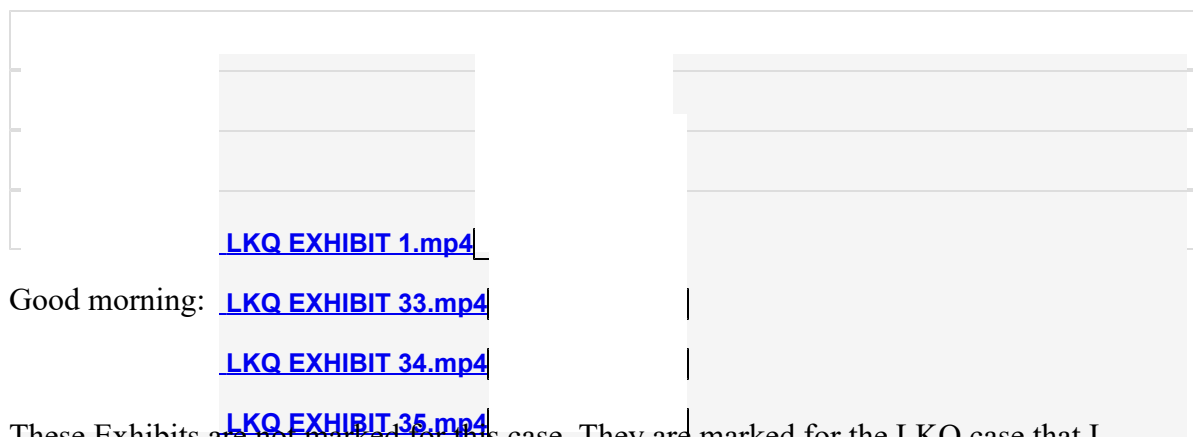
