I do not have any cash or checking accounts



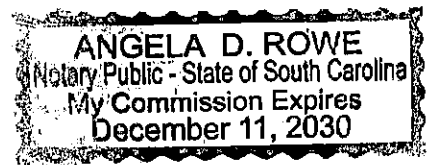

cost of said proceeding or give security thereof.

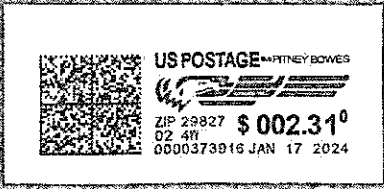
