I have concerns that the documents I mailed did not arrive at your location. The party I am up against is also in control of my mail.

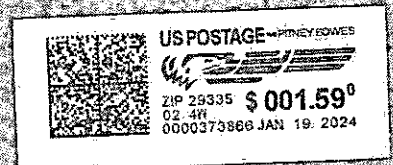
