
Dear Clerk Kitchens:

Would you please be so kind as to file and docket the Notice of Appeal? Please advise me if you have any questions. Thank you.

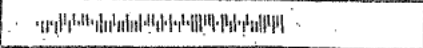
