
NOTICE OF APPEAL

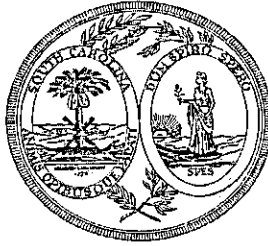
