

Even if the testimony were deemed to be necessary, the Appellant has not requested the transcript timely. Supreme Court Rule 207(a) requires that the testimony be ordered within ten (10) days from the notice of appeal. The notice of appeal in this case was filed on January 25, 2023. If testimony from the trial of Judge Caldwell has been ordered, the undersigned has received no notice.


