MOTION FOR AN EXTENSION OF TIME
TO FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Robert Lee Reddock respectfully requests an extension of thirty (30) days from January 26, 2024 until February 26, 2024 in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.

2. Counsel for Robert Lee Reddock respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Anthony Briggs v. State with the Supreme Court on December 18, 2023. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Keith Vincent Brown with the Court of Appeals on December 13, 2023. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Terrio J. Thomas with the Court of Appeals on December 4, 2023. Counsel filed the Petition for Rehearing in the case of The State v. Levy Larkin Brown with the Court of Appeals on November 22, 2023.

4. Counsel makes this request in good faith and not for purpose of delay.


