I, MARY GRIFFITH, am the Plaintiff. I do not have the funds available to pay the costs of filing and service in the present matter.

I hereby request that my filing fees be waived on the basis that I lost work and income over the past several months, having no income over the past at least 3 months because of working on these other urgent related criminal matters and having to move/flee the area on account of terrorism while assembling evidence against them and struggling to survive.

My losses were/are perpetuated due to organized criminal activity against me. Please minimally consider temporarily waiving my filing fees. I understand that the Court may assess costs against either party at hearing.

I'm preparing my income proofs which include basically small donations (usually \$5, \$10, \$15) from several individuals because I'm off social media and don't currently interact with many people. I've been staying with friends who care about resolving these issues, as do the folks who donate small amounts. The highest amounts were around \$140 and \$150 or so in December to combine for an emergency AirBnb after I received death threats stating that the Subject knew where I was, and that my body would never be found. It's otherwise usually been \$0 or very low because of these kinds of matters.
