In their Motion to Dismiss Appeal filed November 20, 2012, Respondents herein sought dismissal of this appeal as it involves a non-final, interlocutory order not subject to immediate review pursuant to the holding of the South Carolina Supreme Court in *Bone v. U.S. Food Service*, 399 S.C. 566, 733 S.E.2d 200 (Aug. 1, 2012). Following briefing by the parties, your office wrote to counsel of record to advise that this matter would be held in abeyance "pending the action of the Supreme Court on the petition for rehearing in *Bone*" Thereafter, the South Carolina Supreme Court reaffirmed its prior holding dismissing the appeal as interlocutory and not subject to immediate appellate review. See *Bone v. U.S. Food Service*, Op. No. 27278 (S.C.Sup.Ct. filed June 25, 2013) (Shearouse Adv.Sh. No. 28 at 49).

In light of the Supreme Court's holding in *Bone*, and for the reasons stated in their Motion to Dismiss Appeal and their Reply to Appellant's Reply to Motion to Dismiss Appeal, Respondents hereby renew their motion and respectfully submit they are entitled to an order dismissing this appeal in its entirety pending a final judgment by the South Carolina Workers' Compensation Commission.


