

6. That I am asking the Court to waive the motion filing fee.

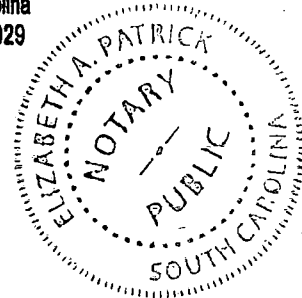
