**Second Motion for Extension of Time
to File Appellant’s Initial Reply Brief**

Pursuant to Rules 208(a)(3) and 240 of the South Carolina Appellate Court Rules, Appellant Airbnb, Inc. respectfully requests a 10-day extension of time to file its Initial Reply Brief. Respondent Julianne Foster moved the Court to file her initial brief out of time on January 12, 2024. The Court issued its order granting the motion on January 22, 2024, making the deadline for Airbnb’s Initial Reply Brief February 1, 2024. Rule 208(a)(3), SCACR. Appellant then moved the Court for a 10-day extension of time to file its Initial Reply Brief. The Court

issued the order granting the motion on January 24, 2024, making the deadline for Airbnb's Initial Reply Brief February 12, 2024.

Undersigned counsel is preparing for two oral arguments scheduled by the South Carolina Supreme Court on February 6, 2024, so Airbnb requests an additional ten days from its current deadline to file its Initial Reply Brief. The proposed extended deadline would run through Thursday, February 22, 2024.

This is Appellant's second request for an extension of time for this Brief. The requested extension will not prejudice any party, and Respondents consent to this extension. Appellant respectfully requests the Court hold the current deadline in abeyance pending the Court's consideration of this Motion.
