NOTICE OF APPEAL

Edward D. Jones & Co., L.P., ("Edward Jones") appeals the Form 4 Order of the Honorable Paul M. Burch dated May 16, 2013 denying Edward Jones's Motion to Compel Arbitration of Defendant's Motion for Damages and Motion to Expedite Plaintiff's Motion to Compel Arbitration and Stay Defendant's Claim for Damages Pending Resolution of It's Arbitrability. Edward Jones filed a Motion for Reconsideration of the May 16, 2013 Order and received notice of the denial of the Motion for Reconsideration on June 24, 2013 ("First Motion for Reconsideration"). Edward Jones also appeals the Order Denying the First Motion for Reconsideration.

In addition, Edward Jones appeals the two separate orders of the Honorable Paul M. Burch, dated June 24, 2013 as follows: 1) Order denying Plaintiff's Motion to Compel Arbitration and Granting Defendant's Motion to Recover Under the Security Bond; and 2) Order Denying Motion to Strike. Edward Jones received written notice of

the entry of the June 24, 2013 Orders on July 2, 2013. On July 5, 2013, Edward Jones filed a Motion for Reconsideration of the Order Denying Plaintiff's Motion to Compel Arbitration and Granting Defendant's Motion to Recover Under the Security Bond ("Second Motion for Reconsideration"). Edward Jones received written notice of the entry of the Order Denying the Second Motion for Reconsideration on July 18, 2013. Edward Jones also appeals the Order Denying the Second Motion for Reconsideration. A copy of each of the Orders is attached hereto.


