Motion of Appeal for Petitioner; Amos LORENZO MYERS

(A) My Lawyer was not prepared for trial. He himself submitted a motion and I submitted two motion to terminate my Lawyer. The judge refused to do so, saying I did not have just cause to terminate him.

(B) My Lawyer scott Suggs was unprepared for DNA evidence and did not HIRE a DNA specialist that was needed to defend against DNA evidence.
