I will wait for those more materials and please send them to me.

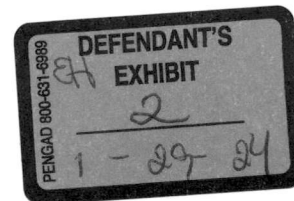
I could download all of them you've kindly sent to Maki. Thank you very much.
