MOTION FOR AN EXTENSION TO SERVE AND FILE

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Michael T. Means with the Supreme Court on January 12, 2024. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Levy L. Brown with the Supreme Court on January 11, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Corey T. Busch with the Court of Appeals on January 8, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.


