Dear Ms. Kitchings:

I am in receipt of the Court's letter of February 7, 2024 regarding expiration of time for service of the Record on Appeal by Appellant-Respondent Fast Formliners Company ("Fast Formliners"). In response to this letter, my paralegal contacted the case manager, Khee'Asia Evans-Pryor, regarding our pending request to hold the deadline for service of the Record on Appeal in abeyance. Ms. Evans-Pryor suggested that we send a letter requesting clarification.

On January 22, 2024, I wrote to the Court of Appeals requesting correction of the December 28, 2023 Order of Transport. The Court issued an Amended Order of Transport on January 31, 2024 giving Fast Formliners 30 days (until March 1, 2024, by my calculation) from the date of the Amended Order to obtain Plaintiff's Trial Exhibit 6 (Videos on Flash Drive) from the trial court and deliver it to the Court of Appeals.

Also submitted on January 22, 2024 was my letter to the Court filing Fast Formliners' Motion to Amend Its Designation of Matter. This Motion moved to include Plaintiff's Trial Exhibit 6 added to the Designation of Matter. In that letter, we requested that the January 29, 2024 deadline for service of the Record on Appeal be stayed until the Motion to Amend was ruled upon by this Court. My records indicate that no Order has been received on this Motion, and I do not see one in the Appellate Case Management System.

I would appreciate guidance from the Court regarding service of the Record on Appeal and will be happy to proceed with the actions or filings that you recommend.


