This court filed an opinion in the case on 1-17-2024 which Appellant received on 1-19-2024. On 1-26-2024, Appellant filed a motion for an extension of time to file a petition for rehearing which there was an error in the caption of that motion. Appellant is amending this motion to correct the caption and any deficiencies in this matter which appear to be overlooked by the appellant as this is a motion for an extension of time to file appellant's petition for rehearing or rehearing En Banc. Appellant, Nelson L. Bruce, hereby moves pursuant to Rule 263(b), SCACR, for a 30-day extension of time from the current deadline in which to serve and file Appellant's Petition for Rehearing of Matters in this case. The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. The deadline for filing a petition for rehearing is February 1, 2024.
2. Plaintiff is currently working on filings for his pending Federal District Court Case (Bruce v. REV Federal Credit Union, et al. case no. 2:22-cv-01292-BHH-MGB) which the deadlines are approaching on.
