number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Christopher A. Comer with the Court of Appeals on February 1, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. TyChristian Ladson with the Court of Appeals on January 31, 2024. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of David James Lamont Brice v. State with the Supreme Court on January 25, 2024. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Michael T. Means with the Supreme Court on January 12, 2024.

4. Counsel makes this request in good faith and not for purpose of delay.

5. On January 31, 2024, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through February 29, 2024.
