To the Court and/or Clerk deciding my case events:

I have moved again because my roommate hadn't wanted to be good. My WiFi was just restored. I apologize for my many delays. I apologize for not getting my brief or Designation of Matter in by today as you previously mandated. I understand it is likely that you will dismiss my claims because of this, but I'm asking you to please continue to review my circumstances and help me if you are able to do so.

I became very upset about the FBI reports and other things. I'm not doing well emotionally. I'm also overwhelmed circumstantially in still trying to get back on my feet.

I see now that I put inappropriate content, especially for the proposed venue, but probably at all into the LKQ lawsuit which I hoped would fund my exoneration and completion of this action because I was upset and triggered when I composed that lawsuit.

Because I am overwhelmed, it only recently came to my attention that the lower court wouldn't want to file something that presented that much liability to the area, as well as awkwardness.

I'm editing it and re-filing it elsewhere now that I've calmed down a little surrounding that content.

In addition, I have a serious problem with God telling me to report another official there locally, but this being the first time I was shown someone wherein I do not actually know what the person did wrong — not to the extent of the pressure. It wouldn't have been anything I would have myself introduced.

God is showing me the original form over and over again — and the person's name, also repeatedly. I believe this is too much for me on top of the need to document my claims and exonerate myself against a terrorist gang herein. I am speaking to the pastor and still urgently seeking counsel. I would never report someone if I didn't know what they did, and I haven't had a chance to review what they did.

I have legitimately been terrorized by the Defendant and believe I can demonstrate that to you. The Defendant, in the past, has persecuted me for allegedly receiving public benefits and being on disability (in a larger pattern of persecution of the poor). I've never been on disability and just recently was approved for food assistance, which I wouldn't mention in a pleading because of the Defendant, but I'm telling you that. There was actually fraud on my food card, so I don't even have the benefit of that in order to provide some relief. There is a case number for that if you want it.

If you haven't closed my case already, I plan to have better documentation for you by Monday now that I'm back online. Thank you for your consideration. I apologize.
