1) Ineffective assistance of counsel;

In reviewing the record I (Henry Sanchez told Counsel "I didn't shoot none.") She never tried to look into my case and follow-up on nothing I told her.  
"Failure to inform a client of his U.S. Const. amend. V. rights and the consequences of exercise and waiver of those rights falls below an objective standard of reasonable representation.

She never explained nothing to me. Prince v. State, 301 S.C. 422 392 S.E. 2d 462 (1990). It is my view that the majority errs when it engages in speculation whether respondent would have fared better had he exercised the right he did not know he possessed. The evidence is uncontested that respondent was never informed of his 5th amendment right to testify, and therefore we must affirm the PCR order granting respondent a new trial. Cherry v. State, 300 S.C. 115 386 S.E. 2d 624 (1989).

2) Reconsideration of sentencing; 23 years for something I did not do. I told my counsel I did not shoot no one.


3) Guilty Plea; I was told if I ain't take it I would get 40 plus years. I was scared into taking this plea my counsel never took the time to talk nothing over with me. She made the decision for me. I did not understand nothing
