2. Counsel filed the Initial Reply Brief of Appellant in the case of The State v. Justin



The State with the Supreme Court on February 15, 2024. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Lee Dell Bradley v. The State with the Supreme Court on February 8, 2024. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Levy Larkin Brown v. The State with the Supreme Court on January 26, 2024. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Driscoll Riggins, Jr. with this Court on January 25, 2024. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Jody Thompson v. The State with the Supreme Court on January 16, 2024. Counsel filed the Petition for Rehearing in the case of The State v. Carnie Norris with this Court on January 4, 2024.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.




