S.C. SUPREME COURT

I OBJECT TO THIS COURTS DECISION TO NOT GRANT MY WRIT OF CERTIORARI WHICH WAS FILED FEBRUARY 20, 2024 AND I DEMAND THAT "ALL" DOCUMENTS BE RETURNED TO ME IMMEDIATELY WITHOUT REBUTTAL SINCE THIS COURT REFUSES TO FILE THE DOCUMENTS.

I ALSO OBJECT TO THE WRIT OF CERTIORARI FILED BY COUNSEL WANDA H. CARTER ON MY BEHALF. SINCE BEING APPOINTED TO MY CASE SHE HAS BEEN INEFFECTIVE IN VIOLATION OF RULES OF PROFESSIONAL CONDUCT 1-4. 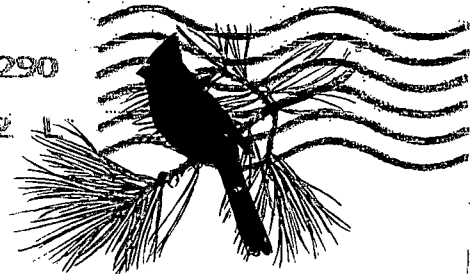
