Counsel for appellant respectfully requests a thirty (30) day extension, in which to serve and file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Bradley Walker with the Court of Appeals today, March 4, 2024. Counsel represented petitioner in a PCR reconstruction hearing in the case of Jacoby Fields v. State via WebEx


hearing on February 26, 2024. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Nathaniel Hambleton v. State with the Supreme Court on February 22, 2024. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Frederick Jones v. State with the Supreme Court on February 12, 2024. Counsel represented petitioner in a PCR reconstruction hearing in the case of Jacoby Fields v. State via WebEx hearing on February 6, 2024. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Antone B. Ellis Tremayne Blakely with the Court of Appeals on February 5, 2024. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of David Welch v. State with the Supreme Court on January 26, 2024. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Devante Lamont White with the Court of Appeals on January 16, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Christopher Shumpert with the Court of Appeals on January 16, 2024. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Tronahz J.S. Whittington with the Court of Appeals on December 15, 2023.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


