1. Initial briefs and designations of matter for each side: January 5, 2024;

3. Reply briefs and designations of matter for each side: May 3, 2024.

It is not anticipated that this schedule will delay the appeal, and each party preserves all rights and objections of all sorts.

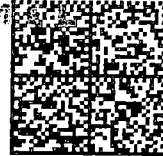

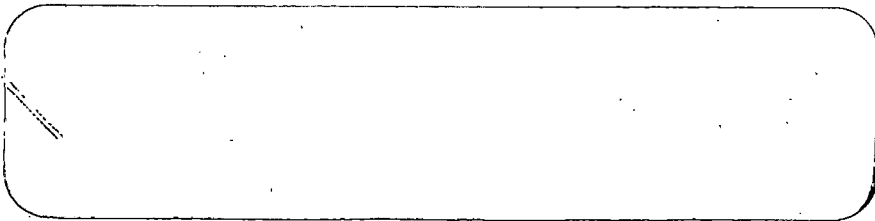

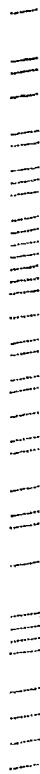
