The above-referenced case is set for oral arguments **Wednesday March 6, 2024 at 10:40 a.m.** The parties to the appeal have settled their case in concept as a result of lengthy mediation and post-mediation negotiations. There is a companion case pending in circuit court which will be settled as well as part of a global deal.

We are in the process of finalizing and executing the settlement documents- some of which will need to be filed in circuit court. Additionally, the settlement involves certain affirmative acts to take place over the next few months to effectuate the terms.

I respectfully request that this case be removed from the docket for next week and the Remittitur held for 90 days to give us time to finalize the settlement of this case. If the settlement is not finalized, we would like leave to reinstate the appeal for purposes of proceeding with the oral arguments.
