MOTION FOR EXTENSION OF TIME TO AMEND THE APPELLANT'S INITIAL BRIEF

1. Appellant filed an Initial Brief in this matter on July 10, 2023.
2. The Respondent filed three extensions to respond to the Appellant's Initial Brief which were on: (1) August 11, 2023, (2) September 11, 2023, and (3) October 12, 2023, respectively. Each of the Respondent's requests were granted by this Court.
3. On November 8, 2023, the Respondent filed a Motion to Strike and Require Filing of an Amended Initial Brief by the Appellant.
4. Thereafter, on January 9, 2024, this Court issued an Order requiring the Appellant to file an Amended Initial Brief in accordance with the Respondent's Motion.
5. The Court recently issued an Order on February 27, 2024, requiring the Appellant to file and serve the Amended Initial Brief within ten days of the receipt of the Order or the appeal would be dismissed.
6. Counsel for the Appellant is requesting a continuance until April 12, 2024, to respond to the Court's request as she has been written out of work by her primary care physician due to illness from October 10, 2023, to March 18, 2024. (See Attachment- letters from Dr. Robyn Brewer, physician for the Appellant's counsel).
7. This motion is not being made for purposes of delay; rather, the Appellant's counsel has health concerns and is under her physician's care.
8. Accordingly, Appellant requests an extension of time until April 12, 2024, to file and serve the Appellant's Amended Initial Brief as her physician's restrictions are not expected to be lifted until March 18, 2024. Further, the Appellant asks that all timelines are held in abeyance until a decision has been made by this Court on this Motion.
