We would like to add for consideration: SC Minimum Standards, SCDC Policy, SC State Constitution, US Constitution, Universal Declaration of Human Rights (UDHR), International Covenant of Civil and Political Rights (ICCPR), and International Covenant on Economics Social and Cultural Rights.

PETITION: F3B UNIT

This is our 1st Amendment right in accordance to the United States Constitution, and also of the South Carolina State Constitution, to form a petition, exercise freedom of speech, and to peaceably assemble.

We hereby form this petition to redress the negligence and damage we endure as prisoners and as citizens here at Lee Correctional Institute, specifically in F3B unit.

The following damages and negligence listed hereafter, constitutes state and federal offences, both amounting to civil and criminal violations of law.

The following damages of neglect are:

- Showers: We are deprived weekly and daily of showers. Some weeks we are lucky to get at least one; this is an 8th Amendment violation and a violation of policy.
- Mail: We are deprived of our unit's mailbox, by it randomly being brought into our unit every 3-4 days. Also, we are being denied legal materials.

This is a 1st, 4th, 8th, and 14th Amendment violation.

- Law Library: We are deprived of fundamental rights to accessing legal materials. We all have cases and legal situations; by placing stipulations on our access to the Law Library, it becomes an obstruction of justice and an interference of legal proceedings and court. This is a 1st, 4th, 8th, 9th, and 14th Amendment violation.

- Chaplain Services: We are deprived access to the chaplain; by not being allowed to attend services or study. This is a 1st, 4th, 8th, and 14th Amendment violation.

- Rec: We are deprived and discriminated against by being denied rec when it is our day to come out. This is a violation of policy and of the 4th and 14th Amendment.

- Food: We are deprived of the proper nourishment of meals, by being fed cold meals throughout the day. We can not eat certain foods without the proper temperature provided to them. By the effects of this, we are missing valuable calories and nutrients. This is a 4th and 8th Amendment violation; and it falls

below the minimum standards of our care.

- Officer(s): We are neglected and mistreated as a whole unit by officers who work within and over our unit. Officers tend to favor F3A with rec and showers, and leave us, F3B, soiled and locked behind our doors. This is a neglect of duty and a misconduct of public officers. Also, this is a 4th, 8th, and 14th Amendment violation.

In conclusion, these acts of negligence result to the following violations of law:

- § 8-1-60: Neglect of duty (SC Code of Laws)
- § 8-1-80: Misconduct of public officer; office declared vacant (SC Code of Laws)
- § 16-5-10: Conspiracy against civil rights (SC Code of Laws)
- § 16-17-410: Conspiracy (SC Code of Laws)
- 18 USC § 241: Conspiracy against rights of citizens (United States Code)
- 18 USC § 242: Deprivation of rights under color of law (United States Code)
- 18 USC § 371: Conspiracy to commit offense or to defraud the United States (United States Code)
- 18 USC § 471: Obligations or securities of United States (United States Code)

- 18 USC § 1505: Obstruction of proceedings before departments, agencies, and committees (United States Code)
- 18 USC § 2381(5): Domestic Terrorism (United States Code)
- 42 USC § 1985: Conspiracy to interfere with civil rights (United States Code)

We demand for relief to be sought and in correlation to the United States Constitution, the South Carolina State Constitution, and the Universal Declaration of Human Rights.
