This letter has several purposes as listed below, I, II, III, IV, V, and VI.

On January 25, 2024, I mailed to the South Carolina Court of Appeals, to your office, the Appeal on Judge Deborah R. McCaslin, appealing her last Order of January 11, 2024, which is related to the two prior orders of May 24, 2023, and April 27, 2023.

On February 6, 2024, Clerk Harrison wrote a letter in which she buried the New Appellate Case of 2024 -000131 under a different Appellate Case Number of 2023 - 001023.

As of today, March 6, 2024, I have not received communication from you that the FIRST TRANSCRIPT ORDER was received, nor have I had any communication from you that the transcript order was assigned to a court reporter. The transcript order appears on February 5, 2024, line of the South Carolina Appellate Case Management System under: 2023-001023, to which it was incorrectly assigned. Additionally, I wrote three emails to Ms. Tammie Holmes, the Court Reporter Manager in the Court Administration Office, requesting that she process this request along with another request from Horry County Circuit Court. As of today, I have received no communication from Ms. Tammie Holmes. The transcript order was also attached to an email to Ms. Tammie Holmes

I. SECOND OFFICIAL NOTICE OF TRANSCRIPT REQUEST ORDER

Attached is a SECOND COPY of the FIRST TRANSCRIPT REQUEST ORDER, FORM 800, for this APPEAL. The Transcript date is April 24, 2023, 9:30 A.M. The court reporter is Ms. Julie Kevish. On May 25, 2023, I ordered the transcript and on June 6, 2023, I paid for a copy of the Complete Transcript, but Ms. Kevish produced an incomplete copy. In my last letter, I requested that the Appellate Court require Ms. Kevish to produce a complete copy of the transcript without numerous deletions and omissions.

No one from the Appellate Court Administration, Transcript Office, nor Court Reporter Office has responded to this request.

II. PLEASE ASSIGN A NEW COURT REPORTER TO THIS TRANSCRIPT ORDER

At this time, I would like to request that a Court Reporter other than Ms. Julie Kevish is engaged to produce the transcript from the hearing date April 14, 2023, 9:30 a.m. before Judge Debra McCaslin, Case No. 2020-CP-2605267, 25th Avenue LLC. v. Carol Ann Honeycutt. I understand that I will have to pay for the transcription a second time.

III. PLEASE TELL ME HOW TO OBTAIN AN AUDIO RECORDING OF THIS HEARING.

I wish to purchase a copy of the complete and official recording of Case No. 2020-CP-2605267 from this hearing.

I presume that the audio version of the court hearing does not belong to Ms. Kevish. Please let me know how I can obtain a copy of the audio recording of this hearing so I can hire a Court Reporter to produce a complete record of the hearing.

Please advise me of any additional procedures you require to obtain the transcripts I have ordered.

IV. ACCORDING TO THE SOUTH CAROLINA JUDICIAL BRANCH WEBSITE:

"Once your request is received, court reporters should acknowledge your request in writing within five business days, advising you of the cost to obtain the transcript. Court reporters do not accept personal checks. You will be instructed to send a money order or certified bank check in order to obtain the transcript. "

I ordered this transcript thirty (30) days ago, and have heard from no one. It appears that the Court Administration has not contacted a Court Reporter yet. Could this be done today, please?

V. ADDITIONALLY, ACCORDING TO THE SOUTH CAROLINA JUDICIAL BRANCH WEBSITE:

"If after following this procedure, your request is not acknowledged, or the transcript has not been received, you may contact Court Administration, and we will be glad to assist you. If you are requesting a transcript from digital court proceedings, contact Tammie Holmes, Court Reporter Manager, via email: tholmes@sccourts.org, or at South Carolina Court Administration, 1220 Senate Street, Suite 200, Columbia, SC 29201."

Three emails were sent to Ms. Tammie Holmes on February 27, and 29, 2024. As of today, I have not received a response from Ms. Holmes.

Your assistance in all these requests is most appreciated. I hope to hear from Ms. Holmes today, by email, and to receive communication from a court reporter assigned to these two transcripts very soon.

Please let me know of any additional actions I must take.
