I am filing a court case to have the home declared derelict and a waterproof notice will be placed on the front door of the mobile home for 30 days by the county magistrate. 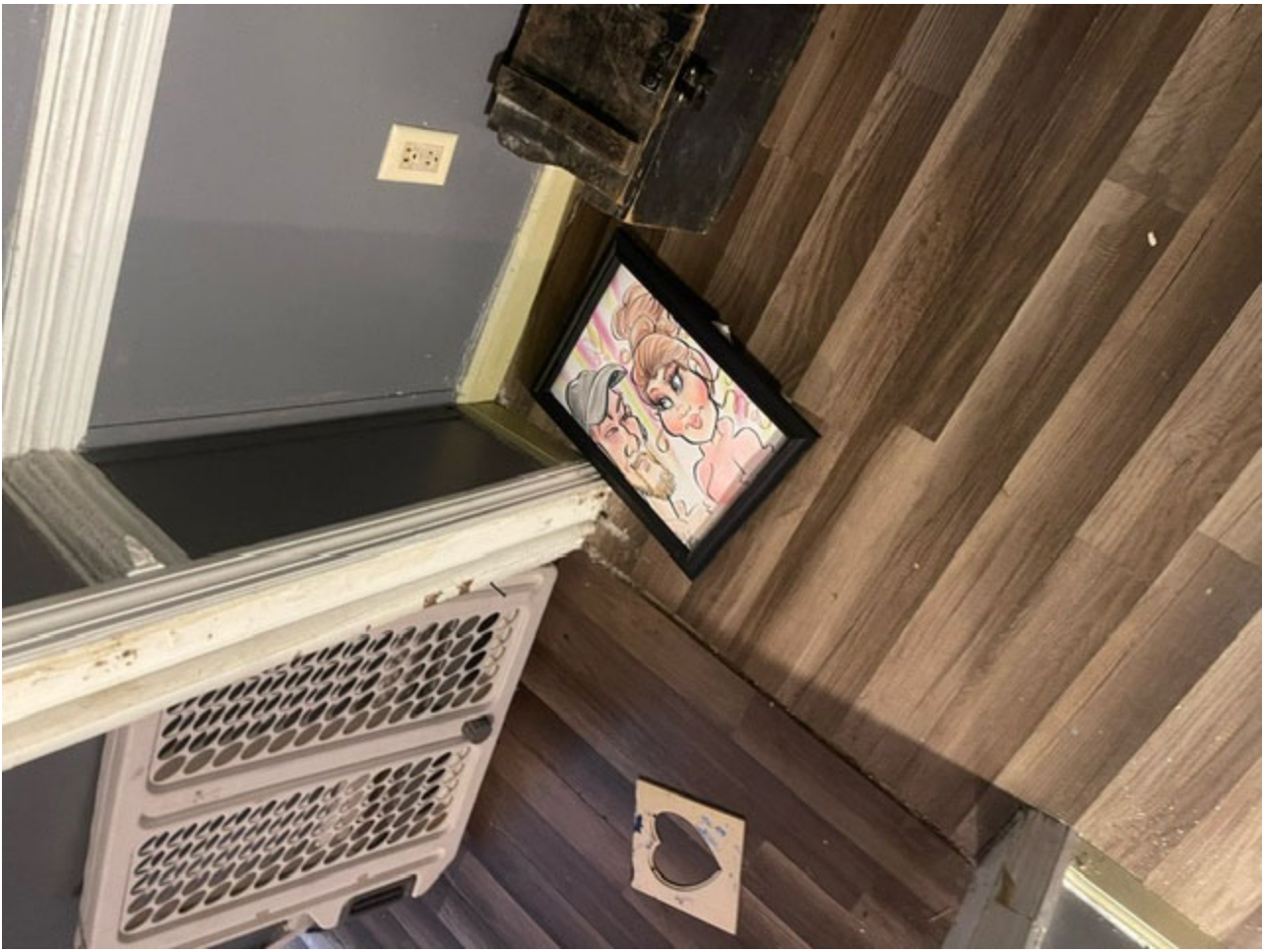


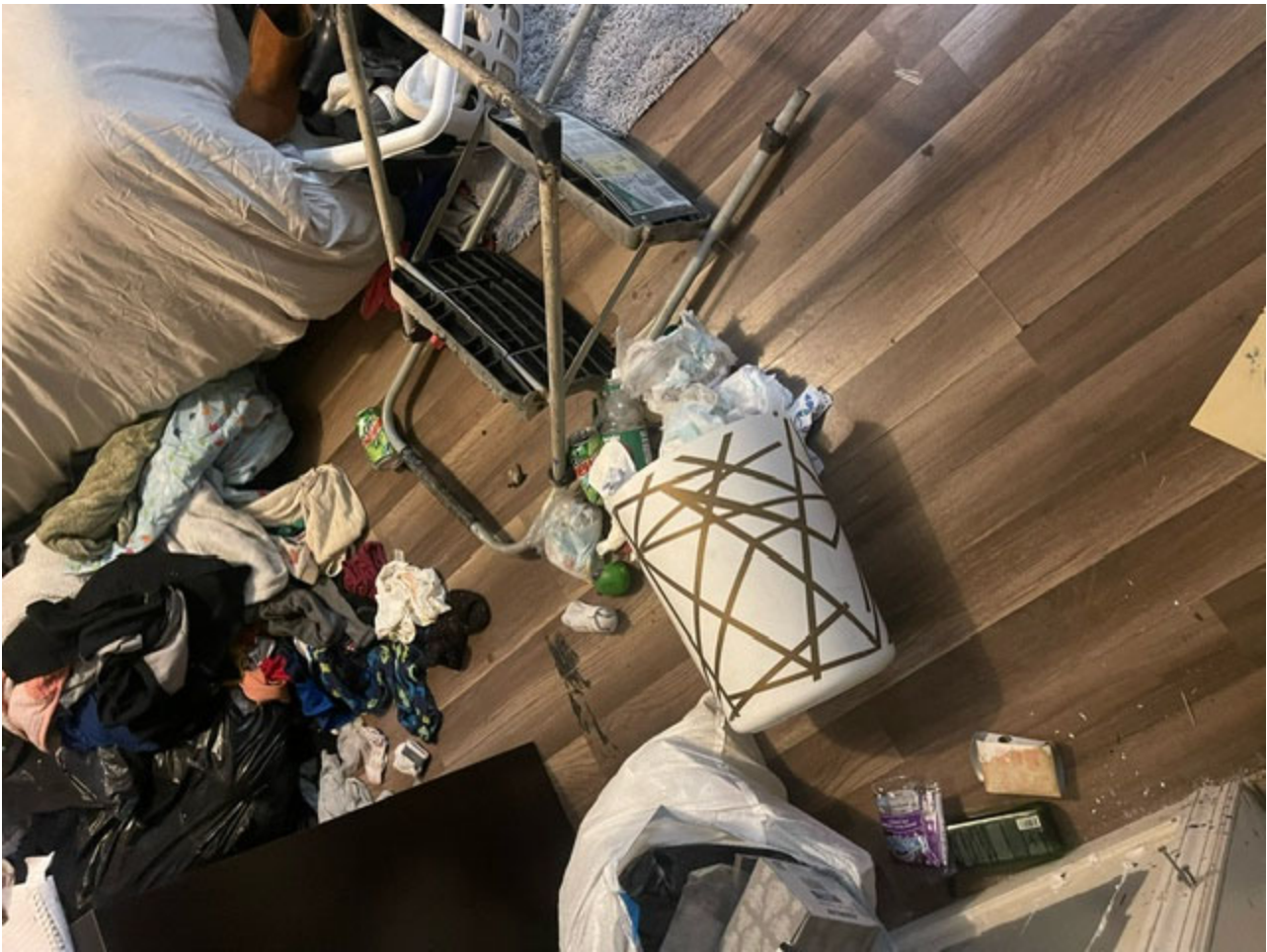
