
NOTICE OF APPEAL

Daniel James Palmino appeals his convictions and sentences in this case. On February 29, 2024, Mr. Palmino pled guilty before the Honorable Eugene C. Griffith, Jr. to the following offenses: Assault and Battery of a High and Aggravated Nature, Grand Larceny Value \$10,000 or more, Financial Transaction Card Theft, Burglary 2nd Degree (Violent), and Domestic Violence 1st Degree. The plea court accepted Palmino's guilty pleas and imposed the negotiated concurrent sentences of: ten (10) years suspended upon the service of five (5) years and five (5) years probation on the Assault and Battery of a High and Aggravated Nature, Grand Larceny, Burglary and Domestic Violence charges crediting him with three hundred ninety-nines days of time-served. On the Financial Transaction Card Theft, Mr. Palmino was sentenced to three hundred ninety-nine (399) days time-served. Mr. Palmino hereby appeals his convictions and sentences.


