

Defendant Savayea Glenn was sentenced to twenty-five years imprisonment on February 7, 2024 following his conviction for drug trafficking. On February 15, 2024, the Court received a motion to reconsider sentence from Defense Counsel, Mr. Hadden Lucas, requesting that Defendant Glenn be given credit from 868 days spent in pre-trial detention.

After reviewing the motion to reconsider, and receiving consent from the State to grant Defendant Glenn credit for the time served in pre-trial detention, the Court hereby grants Defendant Glenn credit for the 868 days that he served in pre-trial detention.
