From the top this all has been going on for some years now. I ended back at my parents home after a bad wreck 3 or 4 years ago they brought me home from hospital I had brain damage and physical injury. I am also adopted pre birth in 1987 before, I'm sure, they did any psychatrac/mental screening. Growing up my dad has told me stories of himself growing up on a farm in Charlotte NC and in Hickory Grove SC during the depression. He has told me whenever they had stray animals like cats or dogs they would put them in a pillow case with a rock to weigh it down and throw them in the pond to get rid of them. I am the most non violent person I know. Any time a disagreement between my dad and I happens he resorts to violence pushing me out doors or striking me with rods, limbs, whatever he can pick up even to the point of shooting at me. I tell you all that not to try to get him in trouble just to let you know what I have been dealing with my whole life. He is my Dad and I do love him. I have never raised a hand or hit or anything past defending/blocking attacks from him. In december I brought a welding machine. I have lots of Scooters Im trying to fabricate into a mini truck. I had not even unboxed my new welder when he came downstairs to the basement and told me not to weld on the scooters inside. I said ok. but he started picking up the frames and throwing them out the door I said, WTF? Then he proceeded to pick up a metal rod to hit me with but the policeman had told me I had every right to defend myself so I picked up a lawnmower blade and smashed it on the ground toward him to let him no I wasn't playing around and had enough of his treatment. He retreated up the stairs and I threw the lawnmower blade at the wall and it stuck into the concrete wall. Then he called the police and they came out took a report and let him know it was just as much him at fault that I was in no wrong. He was fed up with the police at that point for not turning me out of the basement and tried to shoo them out of his house next day he went for an eviction notice less than a week before Christmas. After I was served, it was like the 7th time hes done this. Being at Christmas I had no way to go to the magistrate to argue my case or appeal the eviction. 10 days is all they gave me with no truck, no place to go and no help from anyone else. very hard circumstances beyond my control. But on about Christmas he told me if I cleaned up his yard where he burnt my Camper down I could stay. He even bought me a metal building from lowes

He didn't like my plans for the building so he took it back and called for further ¹⁹ eviction process. So guys came from the County and bagged up my clothes from my bedroom. On my dad's orders we put them on the front porch. He locked up all of my business tools, lawn mowers, chainsaws, weed eaters, blowers, shovels, rakes and misc tools along with my transportation. He refused numerous times to let me have my My jobs everyday. I had also starting fabricating a fish pond to have an aquaponics farm. I also had a family of cats there that I was responsible to come feed every morning. He even continued to keep my food on the porch and inside in refrigerator/freezer for me. long story short my whole life was there and no way I could move or relocate it in 10 days. He continued to let me heat up food and take showers inside against court order. This all continued up to the day of my charge. On the day of 2/2/24 As usual I came to get my tools and feed my cats for the day I noticed he wasn't home; my dad; but my mom was. So I knocked on the door and she let me in. I had to help her back into her seat becuz she almost fell but I helped her she asked me to do their dishes so I did. while inside I even baked a cake. Upon arriving home, My dad, became furious I was inside. running me out with a stick as usual: striking me on the elbow, the calling the police on me. They had warned him in the past that he was misusing their power, and it should be a family court matter and what not but since I was evicted I knew that they would straightaway side with him and throw me in jail. As they had done before but allowing me to go home after dropping charges. But this time was different they had 2 charges 1 for my mom and 1 for my dad of same incident and I know they never took a report from my mom. Plus I had 2 trespassing charge one of which was solicited by the officers at a place I was staying where I had belongings in a shed on Forest Winds dr. York sc 29745. No one showed up in court against me not even the police officers that charged me. My public defender came to me and offered a plea deal that contained probation and restraining order and said shed let me think about it.

about 30 mins went by she returned with another deal saying if I plead
no contest they would let me go home that day. I had already been incarcerated
at mass det. center for 30 days. mind you I had been sexually assaulted and
harrassed and thrown into max isolation lock down where I had been spending
my 30 days about 23 1/2 hrs./day locked in a cell with no stimulation (tv/inmate/only with
a bible for 30 days. Only receiving 3 hrs during a 7 day stretch to have any time
Outside my cell to shower/clean, research law on kiosk, or use phone. So of course
being bribed/enticed with my freedom I took the plea. 30 days time served
for 2 counts of Harrassment first degree and 2 counts of trespassing. I felt my
public defender was not totally using her efforts to help me. She was in fact
just going for a plea like the judge and Prosecutor. Plus my Court was
times for 8:30 AM. I didn't get in front of judge till last on the docket before
they closed that day. 2 days after my release I was locked up again
Some circumstances but harsher charges. False charges but harsher charges.
I am innocent of these charges too. While I have been in here in Jail I
Appealed the first charges and was sent a packet into from my public defender.
it contains somebody elses paperwork not even my appeal paperwork to cite
properly for this letter. I believe this is a total mockery of your Courts System
and a vicious attack on my civil liberties and freedoms. I have a near perfect
record of coming to Court and will continue especially since I may be trying for
a lawsuit or something I am still awaiting legal advice. I believe if my charges are not
dismissed upon appeal approval I should be released at least on PR Bond so I can find
a lawyer to officially do this the right way. Thanks for your time and
Consideration.


