Dear Mrs. Harrison:

I represent the Plaintiff/Respondent in this case.

A review of the public filings in this appellate court case shows that an Opinion was filed in this matter on August 2, 2023. It also shows that on August 23, 2023, a letter was mailed to the Anderson County Clerk of Court indicating that the matter was being remitted to the lower court and a copy of the judgment from the Court of Appeals was being enclosed. However, the same thumbnail does not show an actual copy of the opinion being attached to the letter. That letter to the Anderson County Clerk, also indicated that I was copied on the letter, but I did not receive this letter in either an email or in the United States Mail.

I spoke with two people at the Anderson County Clerk of Court's office who indicate that office has no record of receiving the correspondence, the Remittitur, or the opinion. Because the clerk has not received this documentation, all filings I try to make in the Anderson County case are rejected by the Anderson County Clerk, which means I cannot take steps to move this case forward or bring it to a final disposition.

I spoke with Jacklyn Orr in your office on March 21 and asked her to send another copy of the Remittitur and Opinion to the Anderson County Clerk. She said she would have to speak with

a supervisor about what to do. The next correspondence I received from your office was an email with a letter to myself and opposing counsel, signed by Catherine Harrison, attaching a copy of the August 2, 2023 letter to the Anderson County Clerk of Court. See the email string below, and the attachment.

This does not solve the problem that the Anderson County Clerk of Court does not have the Remittitur or the opinion, nor does it directly respond to my oral request that the Remittitur and copy of the opinion be mailed to the Anderson County Clerk of Court.

I do not know why the Anderson County Clerk of Court did not receive the August 23, 2023 Remittitur. However, we all know that things get lost in the mail from time to time. **Therefore, by this letter, I am requesting that your office mail another copy of the Remittitur and the appellate court opinion to the Anderson County Clerk of Court, and copy me on the mailing.** If you decline to do so, please respond with an email specifying your reason for your position.
