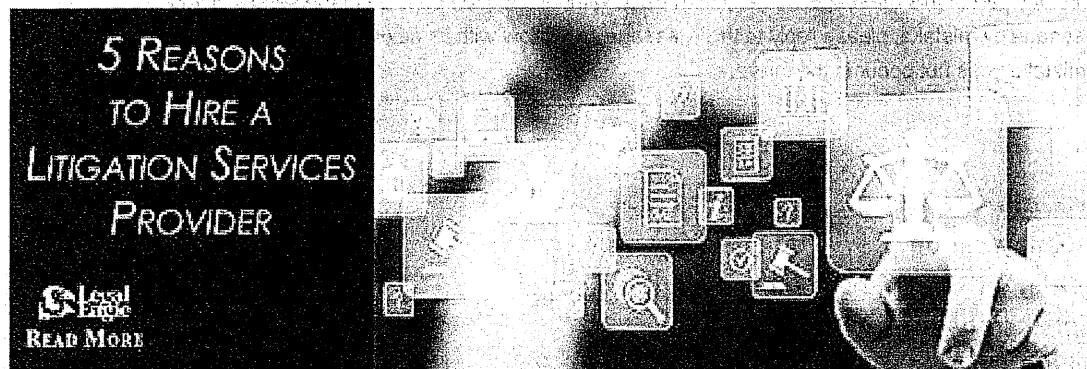
I downloaded and reviewed the audio for this case. It appears we got 12/1's audio twice and did not get 11/30's audio. Could you please send the missing day over? Thanks:
