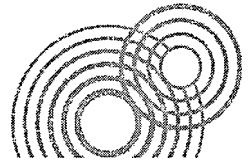


Dear Counsel:
