
**MOTION TO STAY APPEAL
(Writ of Certiorari Pending)**

The Petitioners, Sandvik, Inc. and Sentry Insurance Company, hereby move the Supreme Court of South Carolina for an Order pursuant to Rule 240, SCACR, staying the Petitioners' current Writ of Certiorari pending before this Court. The basis for the Motion to Stay is that the parties have tentatively reached a settlement agreement that is contingent upon the Respondent, Donna L. McCall, receiving a zero dollar Medicare Set-Aside Arrangement (MSA), which should be determined shortly. The Respondent has consented to this Motion to Stay.

For these reasons, Petitioners, by and with the consent of the Respondent, request that the Court in its discretion stay the appeal of this matter until such time as the MSA determination is

made and it can be established whether the contingent settlement can be finalized. If finalized, the parties will notify the Supreme Court and move to dismiss the appeal pursuant to the South Carolina Appellate Court Rules.
