After careful consideration, Respondent's motion to dismiss this appeal is granted. *See State v. Looper*, 421 S.C. 384, 390, 807 S.E.2d 203, 206 (2017) (dismissing the defendant's appeal of the circuit court's order reversing the magistrate's grant of the defendant's motion to suppress evidence and dismissing his DUI charge, holding, "As Petitioner has not been convicted and sentenced, there has been no final judgment, and as no exception to the requirement of a final judgment is applicable under the facts of this case Petitioner's appeal is premature and must be dismissed."). The remittitur will be sent as required by Rule 221(b), SCACR.
